- **Construction contract of a multiple-user industrial development at Tuas South Avenue, Singapore, that is scheduled to be completed by the third quarter of 2025**
- **Precast and prefabrication contract for the supply and delivery of precast components to a HDB project at Kallang Whampoa, that is expected to be completed by the fourth quarter of 2025**
- **The Group's order book has strengthened to S\$1.25 billion and the two new contracts will add more revenue visibility ahead**
